Term. The Agreement will continue in effect through August 31, 2019, unless terminated earlier as set forth in the Channel Partner Terms and Conditions. Microsoft may renew the Agreement for two successive terms, each expiring on August 31st of the then-current year. If Microsoft chooses not to renew, it will provide Company with notice at least 30 days prior to the expiration of the then-current term. Microsoft makes no commitment that it will renew this Agreement or enter into a new agreement with Company.

Applicable Law; Attorneys' Fees. This Agreement is governed by and interpreted in accordance with the laws of Ireland. The parties consent to the exclusive jurisdiction of and venue in the Irish courts for all disputes connected to this Agreement. This choice of jurisdiction and venue does not prevent either party from seeking injunctive relief for: (i) violation of intellectual property rights; (ii) breach of confidentiality obligations; or (iii) enforcement or recognition of any award or order in any appropriate jurisdiction. If either party begins litigation in connection with this Agreement, the substantially prevailing party will be entitled to recover its reasonable attorneys' fees, costs and other expenses. The 1980 United Nations Convention on Contracts for the International Sale of Goods does not govern this Agreement.

Previous Authorization. This Authorization replaces and supersedes all prior Authorizations entered into between Company and Microsoft but only with respect to orders placed under Customer Agreements (as defined in the Channel Partner Terms and Conditions) signed on or after the effective date.

Order of Precedence. In the case of a conflict between any documents in this Agreement that is not expressly resolved in those documents, their terms will control in the following order, from highest to lowest priority: (1) this Authorization, (2) the Channel Partner Terms and Conditions; (3) any documents identified in the table below; and (4) the Program Guides.

In the event of a conflict between the terms and conditions of this Authorization and the Channel Partner Terms and Conditions, this Authorization will control.
